



General Conditions of the organizer O-SEE Sports e.V. / Conditions of participation for the O-SEE Challenge

- I hereby register for the O-SEE Challenge.
- The event is subject to the following competition regulations, terms and conditions and the organizer guidelines and also the competition rules of the German Triathlon Union (DTU) and the legal and disciplinary order, which can be requested from the DTU, and can be downloaded from the homepage of the DTU or can be viewed at the organizers' office on the competition day. I have been informed of any competitions regulations and organizational guidelines. I hereby declare myself in agreement with these and accept these bindingly.
- I accept the anti-doping rules of the National Anti-Doping Agency (NADA) which can be downloaded from the homepage of the NADA or can be requested and viewed on the competition day at the organizers' office.
- I declare that I have trained sufficiently for the participation in this competition, my physical condition and my state of health are medically confirmed.
- I'm aware of the risk of this competition regarding health and other hazards and circumstances and I expressly confirm that I am participating in the event at own risk.
- I accept and agree that I may receive medical treatment at my expense, if it is necessary at the appearance of injuries or in the case of an accident and/or of a disease during competition.
- I acknowledge and I agree that I have sole responsibility for my personal possessions and sport equipment during the O-SEE Challenge and the related activities.
- At the same time, I confirm that I do not have any legal title or claims against the organizer or the organizing committee, the associations involved, all concerned communities or any other persons or bodies, as long as there is no liability insurance claim. This includes all indirect and direct damages as well as all claims which I and my beneficiaries or other authorized person can claim because of received injuries or in case of death.
- I accept and obey all conditions and rules stated in the general and event conditions, laid out by the O-SEE Challenge event team. I will follow the instructions of the organizer and employees. At the same time, I confirm that I oblige and follow the Highway Code, as the event takes place under public traffic conditions.
- I agree that my data provided in the entry form for the O-SEE Challenge and photos, videos and movie shots of myself can be used in the context of reporting and also for the promotion of these and future events without my consent and any reimbursement. This is not the case for commercial use.
- I assure that my indicated birth year is correct and that I will not hand over my start number to anyone else to participate in the event. I'm aware of the fact that I can be disqualified if I change the official race number or do not wear the start number clearly visible or cover a sponsor's message or logo.
- With my signature at the consignment or with the submission of the online form I certify that I have read through the following requirements carefully and in detail and I agree and accept the terms and conditions. At the same time, I certify with my signature at the consignment or with the submission of the online form that I am sufficiently insured against accidents.

Competition regulations, terms and conditions and organisational guidelines from the organiser.

Change and cancellation of the event, refund of the entry fee

- If the organiser is obliged to make changes in the organisation of the event or to cancel it due to official or legal orders, force majeure or for safety reasons, the organiser shall not be liable for damages to the participant, there shall be no claim for reimbursement of the entry fee and there shall be no claim for compensation for other damages such as travel or accommodation costs.

- Refund of the entry fee will only be considered in the event of complete cancellation of the event, if the cancellation is the responsibility of the organiser. If the event has to be cancelled and the organiser is not responsible for the cancellation, the entry fee shall be refunded less the pro rata expenses already incurred by the organiser.
- In the event that the number of participants is subsequently reduced, the participants who cannot start will not be charged by the organiser with any costs; i.e. no processing fees/cancellation fees are to be paid.
- The participant reserves the right to prove in each case that no costs were incurred or that the costs were significantly lower.

Exclusion of liability

- The organiser shall not be liable for damage not caused at least by gross negligence; exceptions to this limitation of liability are damage caused by the culpable breach of a main contractual obligation of the organiser and damage to the life, body or health of a person.
- The aforementioned limitations of liability also extend in particular to personal liability for damages of employees, representatives, vicarious agents and third parties whom the organiser uses in connection with the implementation of the event or with whom it is contractually associated for this purpose.
- The organiser accepts no liability for health risks of the participant in connection with participation in the event. The participant is responsible for his/her own state of health.

Registration / Cancellation

- The services of the organiser are only guaranteed to pre-registered participants.
- Registration is only valid once the entry fee has been received by the organiser.
- Registration is only possible via the event's online registration portal.
- Each participant shall ensure that the personal data provided on registration, in particular the year of birth, is correct.
- The organiser reserves the right to change the announcement, the regulations and the course.
- The entry fee will not be refunded for self-cancelled registrations. Each participant can take out insurance to cover the entry fee at the time of registration if he/she has not taken out insurance elsewhere.
- A change of course/competition after registration or the transfer of the starting place to another participant is possible until the end of the late registration period for a processing fee of 5 euros.
- It is not possible to change the course/competition during the competition.

Miscellaneous

- Helmets are compulsory for all participants on the MTB course.
- Only MTBs from 26" to 29" are permitted for the competition. Exceptions will only be permitted in individual testing. The use of additional drive devices of any kind is not permitted and will lead to disqualification in every case. The technical condition of the MTBs will be checked by stewards before the competition. The stewards are entitled to exclude participants from the competition if their MTBs are not fit for competition.
- In the case of violation of the applicable conditions of participation, especially in case of unsportsmanlike or unfair behaviour towards other participants, or in the case of disregard of instructions of judges, stewards and helpers of the organiser, the participant may be disqualified or not admitted to the competition.
- Participants under 18 years of age require a parental consent form. This confirmation must be presented at the latest when collecting the starting documents.
